CORRECTED ORDER ON MOTION TO DETERMINE CONFIDENTIALITY
OF COURT RECORDS IN A NONCRIMINAL CASE

Plaintiff PRO IMAGE INSTALLERS INC. ("Pro Image"), moved for entry of an order for all it to file certain documents and exhibits under seal to preserve their confidentiality in this action, which Motion to File Exhibits Under Seal, deemed Motion To Determine Confidentiality of Court Records pursuant to Rule 2.420(e), Florida Judicial Administration Rules, was duly noticed for hearing and heard on July 14, 2011. A complete record of the hearing was made by a court reporter secured by Plaintiff.

Upon consideration of the Motion and hearing on the matter, and in accordance with Rule 2.420(e), Florida Judicial Administration Rules, the Court finds:

(A) The case in which this order is entered is a civil contract action between business entities in which Plaintiff seeks preliminary and permanent injunctive relief and damages for its claims of breach of a subcontract agreement between the parties, tortious interference with business relations, and trade libel.

(B) The following grounds for confidentiality under Rule 2.420(c)(9) exist:

- (1) Protect trade secrets; and
- (2) Avoid substantial injury to a party (Pro Image Installers) by disclosure of matters protected by a common law or privacy right not generally inherent in the specific type of proceeding sought to be closed.


(C) The information determined to be confidential is that set forth in Exhibit 1 to Plaintiff's Motion and Amended Motion for Preliminary Injunction, and exhibits thereto, which contain Plaintiff's trade secrets in the form of proprietary pricing information, and email communications and correspondence which shall remain confidential to protect Plaintiff's interests set forth in (B)(2) above.

(D) Persons permitted to view the confidential information are restricted to the parties to this action and their attorneys of record.

(E) The degree, duration and manner of confidentiality ordered herein are no broader than necessary to protect the above interests, and no less restrictive measures are available to protect the interests set forth above. Exhibit 1 to Plaintiff's Motion for Preliminary Injunction, to be filed with the clerk pursuant to a Notice of Filing Confidential Information, shall remain sealed and maintained by the clerk of the court as confidential until further order of this Court.

The clerk of the court is directed to publish this order within 10 days following entry of the order, by posting a copy of the order on the clerk's website and in a prominent public location in the courthouse; said order to remain posted in both locations for no less than 30 days.
